LOCAL STRONG MAGNETIC FIELDS AND THE LITTLE-PARKS EFFECT

ABSTRACT. Starting from the Ginzburg–Landau model in a planar simply connected domain, with a local compactly supported applied magnetic field, we derive an effective model in the strong field limit, defined on a non-simply connected domain. The effective model features oscillations in the Little-Parks and Aharonov–Bohm spirit. We discuss also a similar question for the lowest eigenvalue of the magnetic Laplacian.

1. INTRODUCTION

1.1. The Little-Parks effect. As the applied magnetic flux varies, superconductors undergo phase transitions between normal and superconducting states. The Little-Parks effect is observed when the transition is non-monotone and exhibit oscillations between superconducting and normal phases [14]. Within the Ginzburg-Landau theory, examples of this sort were provided previously in several settings:

- a) Under a constant magnetic field, when imposing a Robin condition [7, 13] or when restricting the superconducting sample to a thin domain [6, 10, 15, 16];
- b) under Aharonov-Bohm magnetic fields [12];
- c) under certain positive non-homogeneous radial magnetic fields [6].

In this paper, we consider a strong local magnetic field and prove that oscillations occur indefinitely in the Little–Parks spirit.

1.2. The local magnetic field. Consider two simply connected domains $\omega, \Omega \subset \mathbb{R}^2$ such that $\overline{\omega} \subset \Omega$, and assume that their boundaries, $\partial \omega$ and $\partial \Omega$, are simple smooth C^1 curves. By a local magnetic field we mean a non homogeneous magnetic field of the form $b\mathbf{1}_{\omega}\hat{z}$, where $\hat{z} = (0,0,1)^{\top}$, b > 0 and $\mathbf{1}_{\omega}$ is the characteristic function of ω ,

$$\mathbf{1}_{\omega}(x) = \begin{cases} 1 & \text{if } x \in \omega, \\ 0 & \text{if } x \notin \omega. \end{cases}$$
(1.1)

This is an example of a magnetic step, which has recently received considerable attention in the context of superconductivity and spectral theory [1, 2, 3, 8]. Corresponding to the magnetic field $b\mathbf{1}_{\omega}\hat{z}$ is the magnetic flux

$$\Phi := \frac{1}{2\pi} \int_{\Omega} b \mathbf{1}_{\omega} \, \mathrm{d}x = \frac{b|\omega|}{2\pi}.$$
(1.2)

We introduce the vector potential $\mathbf{F}: \overline{\Omega} \to \mathbb{R}^2$ defined as

$$\mathbf{F} = (-\partial_2 \phi, \partial_1 \phi), \tag{1.3}$$

where ϕ is the unique solution of

$$-\Delta \phi = \frac{2\pi}{|\omega|} \mathbf{1}_{\omega}$$
 in Ω , $\phi = 0$ on $\partial \Omega$,

and notice that ${\bf F}$ satisfies

curl
$$\mathbf{F} = \frac{2\pi}{|\omega|} \mathbf{1}_{\omega}, \quad \text{div} \mathbf{F} = 0 \text{ on } \Omega, \quad \text{and } \nu \cdot \mathbf{F} = 0 \text{ on } \partial\Omega, \quad (1.4)$$

where ν is the unit normal to $\partial\Omega$ pointing inward Ω . Hence, $\Phi \mathbf{F}$ is a vector potential corresponding to the magnetic field $b\mathbf{1}_{\omega}\hat{z}$, as $\operatorname{curl}(\Phi \mathbf{F}) = b\mathbf{1}_{\omega}$ in view of (1.2).

1.3. The Ginzburg-Landau model. Let us suppose that Ω is the cross section of a cylindrical superconductor subject to the magnetic field $b\mathbf{1}_{\omega}\hat{z}$, with corresponding magnetic flux Φ in (1.2). As the magnetic flux Φ increases, it is well known that the superconductor undergoes a phase transition between the superconducting and normal states. The state of superconductivity is described by a configuration (ψ , **A**) such that

$$\psi: \Omega \to \mathbb{C}, \quad \mathbf{A}: \Omega \to \mathbb{R}^2,$$

with $|\psi|^2$ representing the local density of superconductivity, curl **A** representing the local induced magnetic field, and

$$\mathbf{j}(\psi, \mathbf{A}) := \operatorname{Re}\langle \psi, (-\mathrm{i}\nabla - \mathbf{A})\psi \rangle_{\mathbb{C}}$$
(1.5)

measures the supercurrent. At equilibrium, the physically interesting configurations are the minimizers (or even critical points) of the energy functional

$$\mathcal{E}_{\Phi}(\psi, \mathbf{A}) = \int_{\Omega} \left(|(-i\nabla - \Phi \mathbf{A})\psi|^2 - \kappa^2 |\psi|^2 + \frac{\kappa^2}{2} |\psi|^4 + \Phi^2 |\operatorname{curl}(\mathbf{A} - \mathbf{F})|^2 \right) dx, \quad (1.6)$$

defined on the following function space

$$\mathcal{H} = \{(\psi, \mathbf{A}) \in H^1(\Omega; \mathbb{C}) \times H^1(\Omega; \mathbb{R}^2) \colon \operatorname{div} \mathbf{A} = 0 \text{ on } \Omega, \ \nu \cdot \mathbf{A} = 0 \text{ on } \partial\Omega \}.$$
(1.7)

The definition of the functional \mathcal{E}_{Φ} involves a positive constant κ called the Ginzburg– Landau parameter, which is a characteristic of the superconducting material. Throughout this paper, κ will be fixed.

We introduce also the ground state energy $E(\Phi)$ of the functional \mathcal{E}_{Φ} as

$$E(\Phi) = \inf \{ \mathcal{E}_{\Phi}(\psi, \mathbf{A}) \colon (\psi, \mathbf{A}) \in \mathcal{H} \}.$$
(1.8)

We say that a configuration (ψ, \mathbf{A}) is a minimizer of \mathcal{E}_{Φ} if $(\psi, \mathbf{A}) \in \mathcal{H}$ and $\mathcal{E}_{\Phi}(\psi, \mathbf{A}) = E(\Phi)$.

1.4. The effective model. Our aim is to understand the behavior of $E(\Phi)$ and the minimizing configurations in the limit of large Φ (which by (1.2) is equivalent to the limit of large b). We will show that the strong magnetic field in the interior domain ω will essentially force the minimizing ψ to be zero there. This motivates the introduction of an effective functional, defined on the space

$$\mathcal{H}_0 = \{ (u, \mathbf{A}) \in \mathcal{H} \colon u = 0 \text{ on } \omega \}, \tag{1.9}$$

as

$$\mathcal{G}_{\Phi}(u,\mathbf{A}) = \int_{\Omega_0} \left(|(-i\nabla - \Phi \mathbf{A})u|^2 - \kappa^2 |u|^2 + \frac{\kappa^2}{2} |u|^4 \right) dx + \Phi^2 \int_{\Omega} |\operatorname{curl}(\mathbf{A} - \mathbf{F})|^2 dx,$$
(1.10)

where $\Omega_0 := \Omega \setminus \overline{\omega}$. Note that \mathcal{G}_{Φ} acts on configurations (u, \mathbf{A}) where the function u has support in the non-simply connected domain Ω_0 . We can and will view it as being defined in Ω_0 with a Dirichlet boundary condition u = 0 on $\partial \omega$. In fact, thanks to the smoothness of $\partial \omega$, a function u belongs to the space

$$\mathcal{X}(\Omega_0) = \{ u \in H^1(\Omega_0; \mathbb{C}) \colon u = 0 \text{ on } \partial \omega \}$$
(1.11)

if and only if it has an extension $\widetilde{u} \in H^1(\Omega; \mathbb{C})$ and $\widetilde{u} = 0$ on ω .

The functional \mathcal{G}_{Φ} turns out to be the relevant approximation of the functional \mathcal{E}_{Φ} in the limit of large Φ . We describe this approximation in Theorem 1.1 below, which involves the effective ground state energy that we define as

$$G(\Phi) = \inf \{ \mathcal{G}_{\Phi}(u, \mathbf{A}) \colon (u, \mathbf{A}) \in \mathcal{H}_0 \}.$$
(1.12)

Thanks to invariance under gauge transformations, it suffices to study $G(\Phi)$ for $0 \le \Phi < 1$. In fact, on Ω_0 , we define the function

$$U_n(x) = \exp\left(\mathrm{i}n \int_{\ell(x_*, x)} \mathbf{F} \cdot \mathrm{d}r\right), \qquad (1.13)$$

where x_* is a fixed point in Ω_0 and $\ell(x_*, x)$ is any path in Ω_0 connecting x_* and x. The definition of U_n is independent of the choice of the path and the relevance of U_n is that it is C^1 smooth and satisfies (see [5, p. 21])

$$\nabla U_n = \mathrm{i} n U_n \mathbf{F} \text{ on } \Omega_0. \tag{1.14}$$

Consequently, we have the following identity

$$U_n^{-1}(-\mathrm{i}\nabla - \Phi \mathbf{F})U_n = -\mathrm{i}\nabla - (\Phi - n)\mathbf{F}, \qquad (1.15)$$

which allows us to shift Φ by an integer without changing the energy $G(\Phi)$.

Theorem 1.1. As $\Phi \to +\infty$, the ground state energies $E(\Phi)$ and $G(\Phi)$ introduced in (1.8) and (1.12) satisfy

$$\mathbf{E}(\Phi) = \mathbf{G}(\Phi) + o(1).$$

Moreover, it holds the following.

- i) The function $\Phi \mapsto G(\Phi)$ is periodic with period 1.
- ii) If $0 \leq \Phi_0 < 1$ and $(\psi_n, \mathbf{A}_n)_{n \geq 1}$ is a sequence such that, every (ψ_n, \mathbf{A}_n) is a minimizing configurations of \mathcal{E}_{Φ} for $\Phi = \Phi_n := \Phi_0 + n$, then there exists a minimizer $(u_*, \mathbf{A}_*) \in \mathcal{H}_0$ of \mathcal{G}_{Φ_0} and a subsequence (n_k) such that

$$\begin{split} |\psi_{b_{n_k}}| \to |u_*| & in \ H^1(\Omega; \mathbb{C}), \\ U_{n_k}^{-1} \psi_{n_k} \to u_* & in \ H^1(\Omega_0; \mathbb{C}), \\ \mathbf{j}(\psi_{n_k}, \mathbf{A}_{n_k}) \to \mathbf{j}_* & in \ L^2(\Omega; \mathbb{R}^2), \end{split}$$

where \mathbf{j}_* is defined as

$$\mathbf{j}_* = \langle u_*, (-\mathbf{i}\nabla - b_0 \mathbf{A}_*) u_* \rangle_{\mathbb{C}}$$

iii) If $\Phi \in \mathbb{N}$, then any minimizer $(u, \mathbf{A}) \in \mathcal{H}_0$ of \mathcal{G}_{Φ} satisfies

$$|u| > 0$$
, $\mathbf{A} = \mathbf{F}$, $\mathbf{j}(u, \mathbf{A}) = 0$.

We will prove Theorem 1.1 in Section 2.

1.5. Oscillations for the effective model. Consider the magnetic Laplacian in the non-simply connected domain $\Omega_0 = \Omega \setminus \overline{\omega}$,

$$\mathbf{H}_{\Phi}^{\Omega_0} = (-\mathbf{i}\nabla - \Phi \mathbf{F})^2 \,, \tag{1.16}$$

with Neumann boundary condition $\nu \cdot \nabla u = 0$ on $\partial \Omega$, and Dirichlet boundary condition u = 0 on $\partial \omega$. Since we do not impose Neumann boundary condition on the inner boundary $\partial \omega$, $\mathsf{H}_{\Phi}^{\Omega_0}$ differs from the Neumann realization considered in [9], but it can still be studied using the same methods as in [9]. The operator $\mathsf{H}_{\Phi}^{\Omega_0}$ has compact resolvent, its spectrum is purely discrete, and its lowest eigenvalue is

$$\lambda_{1}^{\Omega_{0}}(\Phi) = \inf_{\substack{u \in \mathcal{X}(\Omega_{0})\\ u \neq 0}} \frac{\|(-i\nabla - \Phi \mathbf{F})u\|_{L^{2}(\Omega_{0})}^{2}}{\|u\|_{L^{2}(\Omega_{0})}^{2}},$$
(1.17)

where $\mathcal{X}(\Omega_0)$ is the space introduced in (1.11).

With the help of $\lambda_1^{\Omega_0}(\Phi)$, we may characterize whether a minimizer of \mathcal{G}_{Φ} is identically zero or not. Actually, it is straightforward to verify that

$$\lambda_1^{\Omega_0}(\Phi) < \kappa^2 \Longrightarrow \mathcal{G}(\Phi) < 0, \tag{1.18}$$

by using (tv, 0) as a trial state, with v a ground state of $\lambda_1^{\Omega_0}(\Phi)$ and t > 0 sufficiently small. Since $G(\Phi) \leq \mathcal{G}_{\Phi}(0) = 0$, then denoting by u_{Φ} a minimizer of \mathcal{G}_{Φ} , we have that u_{Φ} is not identically zero whenever $\lambda_1^{\Omega_0}(\Phi) < \kappa^2$.

The transition from $u_{\Phi} = 0$ to $u_{\Phi} \neq 0$ is then related to the monotonicity of the eigenvalue $\lambda_1^{\Omega_0}(\Phi)$, which we would like to explore next. The diamagnetic inequality yields that

$$\lambda_1^{\Omega_0}(\Phi) \ge \lambda_1^{\Omega_0}(0) > 0, \tag{1.19}$$

and thanks to (1.15), the following holds.

Proposition 1.2 ([9, Theorem 1.1]). The function $\Phi \mapsto \lambda_1^{\Omega_0}(\Phi)$ is continuous, periodic with period 1, non-constant, and its minimum is attained at $\Phi = 0$ while its maximum is attained at $\Phi = \frac{1}{2}$. Moreover,

$$\lambda_1^{\Omega_0}(\Phi + \frac{1}{2}) = \lambda_1^{\Omega_0}(\Phi - \frac{1}{2}),$$

$$\lambda_1^{\Omega_0}(\Phi) > \lambda_1^{\Omega_0}(0) \quad \left(\Phi \notin \mathbb{N}\right),$$
(1.20)

and

$$\lambda_1^{\Omega_0}(\Phi) < \lambda_1^{\Omega_0}(\frac{1}{2}) \quad \left(\Phi \notin \frac{1}{2} + \mathbb{N}\right). \tag{1.21}$$

Consequently, we get that a minimizer of u_{Φ} oscillates between $u_{\Phi} = 0$ (normal state) and $u_{\Phi} \neq 0$ (superconducting state) as Φ varies.

Corollary 1.3.

- A) There exists a positive constant c_{*} ∈ (0,1] such that the following is true. Suppose that 0 < κ < c_{*}√λ₁^{Ω₀}(1/2), and consider the two sequences (Φ_n := n 1/2) and (Φ'_n := n). Then, for all n ∈ N, we have 0 < Φ_n < Φ'_n < Φ_{n+1} and i) u_{Φ_n} = 0 for any critical point (u_{Φ_n}, A_{Φ_n}) of G_{Φ_n};
 ii) u_{Φ'_n} ≠ 0 for any minimizer (u_{Φ'_n}, A_{Φ'_n}) of G_{Φ'_n}.
- B) If $\kappa > \sqrt{\lambda_1^{\Omega_0}(1/2)}$, then any minimizer $(u_{\Phi}, \mathbf{A}_{\Phi})$ of \mathcal{G}_{Φ} satisfies $u_{\Phi} \neq 0$.

1.6. The magnetic Laplacian with a local magnetic field. In order to investigate the occurrence of oscillations for the initial model in (1.6), one has to study

$$\lambda_{1}^{\Omega}(\Phi) := \inf_{\substack{u \in H^{1}(\Omega; \mathbb{C}) \\ u \neq 0}} \frac{\|(-i\nabla - \Phi \mathbf{F})u\|_{L^{2}(\Omega)}^{2}}{\|u\|_{L^{2}(\Omega)}^{2}},$$
(1.22)

the lowest eigenvalue of the magnetic Laplacian in $L^2(\Omega)$,

$$\mathcal{H}_{\Phi}^{\Omega} = (-i\nabla - \Phi \mathbf{F})^2, \qquad (1.23)$$

with Neumann boundary conditions $\nu \cdot \nabla u = 0$ on $\partial \Omega$. Subject to the local magnetic field $\Phi \operatorname{curl} \mathbf{F} = \frac{2\pi}{|\omega|} \Phi \mathbf{1}_{\omega} = b \mathbf{1}_{\omega}$, this eigenvalue problem is also related to the existence of discrete spectrum for locally deformed leaky wires [4].

Guided by Theorem 1.1, we anticipate that the eigenvalue $\lambda_1^{\Omega_0}(\Phi)$, introduced in (1.17), approximates the eigenvalue $\lambda_1^{\Omega}(\Phi)$ in the limit of large Φ . This can likely be obtained from [11] in the framework of norm resolvent convergence, but we give here another proof which is closer to the one of Theorem 1.1.

Theorem 1.4. As $\Phi \to +\infty$, the eigenvalues $\lambda_1^{\Omega}(\Phi)$ and $\lambda_1^{\Omega_0}(\Phi)$ introduced in (1.22) and (1.20) satisfy

$$\lambda_1^{\Omega}(\Phi) = \lambda_1^{\Omega_0}(\Phi) + o(1).$$

Notice that, by comparing with the Dirichlet problem in Ω_0 , we have the nonasymptotic bound,

$$\lambda_1^{\Omega}(\Phi) \le \lambda_1^{\Omega_0}(\Phi), \quad \forall \, \Phi > 0.$$
(1.24)

To prove Theorem 1.4, we will establish the matching asymptotic lower bound,

$$\lambda_1^{\Omega}(\Phi) \ge \lambda_1^{\Omega_0}(\Phi) + o(1). \tag{1.25}$$

This will be done in Section 3. As a direct consequence of Theorem 1.4, we get that the minimizers of the functional \mathcal{E}_{Φ} in (1.6) undergo indefinite oscillations between the normal and superconducting phases.

Corollary 1.5. Suppose that $0 < \kappa < c_* \sqrt{\lambda_1^{\Omega_0}(1/2)}$, where $c_* \in (0,1)$ is a constant independent of κ and Φ . There exist two sequences (Φ_n) and (Φ'_n) such that, for all $n \in \mathbb{N}$, we have $0 < \Phi_n < \Phi'_n < \Phi_{n+1}$ and

- i) ψ_{Φ_n} = 0 for any critical point (ψ_{Φ_n}, A_{Φ_n}) of E_{Φ_n};
 ii) ψ_{Φ'_n} ≠ 0 for any minimizer (ψ_{Φ_n}, A_{Φ'_n}) of E_{Φ'_n}.

Moreover, if $\kappa > \sqrt{\lambda_1^{\Omega_0}(1/2)}$, then for all $\Phi > 0$, any minimizer $(\psi_{\Phi}, \mathbf{A}_{\Phi})$ of \mathcal{E}_{Φ} satisfies $\psi_{\Phi} \neq 0$.

To construct the sequences in the above corollary, we note that a minimizer of \mathcal{E}_{Φ} is not identically zero whenever $\lambda_1^{\Omega}(\Phi) < \kappa^2$, and we use Proposition 1.2 and Theorem 1.4 to construct (Φ_n) and (Φ'_n) such that $\lambda_1^{\Omega}(\Phi_n) > \kappa^2$ and $\lambda_1^{\Omega}(\Phi'_n) < \kappa^2$.

2. Convergence to the effective functional

In this section we prove Theorem 1.1 and Corollary 1.3. In the various calculations, we will encounter, in addition to the flux Φ , the integer and fractional parts

$$\lfloor \Phi \rfloor = \sup\{m \in \mathbb{Z} \colon m \le \Phi\}, \quad \{\Phi\} = \Phi - \lfloor \Phi \rfloor. \tag{2.1}$$

We start by proving that the effective ground state energy is periodic with respect to Φ . For any $\Phi > 0$ and $n \ge 0$, we define the transformation

$$\mathcal{L}_{\Phi,n}(u,\mathbf{A}) = \left(U_n u, \frac{\Phi}{\Phi+n}\mathbf{A} + \frac{n}{\Phi+n}\mathbf{F}\right).$$

Proposition 2.1. For all $\Phi > 0$, we have

$$\mathcal{G}(\Phi+1) = \mathcal{G}(\Phi),$$

where $G(\cdot)$ is introduced in (1.12). Moreover, with $n = \lfloor \Phi \rfloor$ and $\Phi_0 = \{\Phi\}$, we have (u_*, \mathbf{A}_*) is a minimizer of $\mathcal{G}_{\Phi_0} \iff (u, \mathbf{A}) = \mathcal{L}_{\Phi_0,n}(u_*, \mathbf{A}_*)$ is a minimizer of \mathcal{G}_{Φ} . *Proof.* Let $(u, \mathbf{A}) \in \mathcal{H}_0$, where \mathcal{H}_0 is the space introduced in (1.9). With $\tilde{u} = U_1 u$ and $\tilde{\mathbf{A}} = \frac{\Phi}{\Phi+1}\mathbf{A} + \frac{1}{\Phi+1}\mathbf{F}$, the configuration $(\tilde{u}, \tilde{\mathbf{A}}) \in \mathcal{H}_0$, and thanks to (1.15), we have

$$\mathcal{G}_{\Phi+1}(\tilde{u},\mathbf{A}) = \mathcal{G}_{\Phi}(u,\mathbf{A})$$

Minimizing over $(u, \mathbf{A}) \in \mathcal{H}_0$, we get $G(\Phi + 1) = G(\Phi)$, and if (u, \mathbf{A}) is a minimizer of \mathcal{G}_{Φ} , then $(\tilde{u}, \tilde{\mathbf{A}})$ is a minimizer of $\mathcal{G}_{\Phi+1}$. By iteration, we cover the case where $\Phi = \Phi_0 + n$ and $n \in \mathbb{N}$.

Remark 2.2. Suppose that $\Phi \in \mathbb{N}$. Then, by Proposition 2.1, the set of minimizers of \mathcal{G}_{Φ} is $\{(cU_{\Phi}u_*, \mathbf{F}): c \in \mathbb{C} \text{ with } |c| = 1\}$, where u_* is the unique positive solution of

 $-\Delta u_* = \kappa^2 (1-u^2) u \text{ on } \Omega_0, \quad u_* = 0 \text{ on } \partial \omega, \quad \nu \cdot \nabla u = 0 \text{ on } \partial \Omega.$

Consequently, for a minimizer (u_{Φ}, \mathbf{F}) of \mathcal{G}_{Φ} , we have

$$|u_{\Phi}| > 0$$
, $\mathbf{j}(u_{\Phi}, \mathbf{F}) = \operatorname{Re}\langle u_{\Phi}, (-i\nabla - \Phi \mathbf{F})u_{\Phi}\rangle_{\mathbb{C}} = 0$.

In fact, $u_{\Phi} = cU_{\Phi}u_*$, with |c| = 1 and u_* real-valued, and by (1.13),

$$\langle u_{\Phi}, (-i\nabla - \Phi \mathbf{F})u_{\Phi} \rangle_{\mathbb{C}} = \langle u_*, (-i\nabla - \Phi \mathbf{F} + \Phi \mathbf{F})u_* \rangle_{\mathbb{C}} = iu_*\nabla u_*$$

We next give a non-asymptotic upper bound on the ground state energy $E(\Phi)$.

Proposition 2.3. Let $E(\Phi)$ and $G(\Phi)$ be the ground state energies introduced in (1.8) and (1.12) respectively. Then, for all $\Phi \geq 0$, we have

$$\mathbf{E}(\Phi) \le \mathbf{G}(\Phi) \le 0.$$

Proof. Firstly, $G(\Phi) \leq \mathcal{G}_{\Phi}(0, \mathbf{F}) = 0$. Secondly, letting $(u, \mathbf{A}) \in \mathcal{H}_0$ be a minimizer of $G(\Phi)$, we observe that $(u, \mathbf{A}) \in \mathcal{H}$ and $E(\Phi) \leq \mathcal{E}_{\Phi}(u, \mathbf{A}) = \mathcal{G}_{\Phi}(u, \mathbf{A}) = G(\Phi)$. \Box

To establish an asymptotic lower bound on $E(\Phi)$, we collect below some known estimates on the minimizing configurations of the functional \mathcal{E}_{Φ} (see [5, Prop. 10.3.1 & Lem. 10.3.2]), where $\|\cdot\|_p$ denotes the standard norm on $L^p(\Omega)$.

Proposition 2.4. There exists a positive constant C such that, if $\Phi > 0$ and $(\psi_{\Phi}, \mathbf{A}_{\Phi}) \in \mathcal{H}$ is a minimizer of \mathcal{E}_{Φ} , then

$$\|\psi\|_{\infty} \leq 1, \quad \|(-\mathrm{i}\nabla - \Phi \mathbf{A})\psi\|_{2} \leq \kappa \|\psi\|_{2}, \quad \|\operatorname{curl}(\mathbf{A} - \mathbf{F})\|_{2} \leq \frac{\kappa}{\Phi} \|\psi\|_{2},$$

and

$$\|\mathbf{A} - \mathbf{F}\|_{H^2(\Omega)} \le \frac{C\kappa}{\Phi} \|\psi\|_2.$$
(2.2)

Notice that (2.2) results from the curl-div inequality

$$\|\mathbf{a}\|_{H^2(\Omega)} \le C_{\Omega} \|\operatorname{curl} \mathbf{a}\|_{H^1(\Omega)}$$

valid for any vector field satisfying

 $\mathbf{a} \in H^1(\Omega; \mathbb{R}^2), \quad \operatorname{curl} \mathbf{a} \in H^1(\Omega; \mathbb{R}), \quad \operatorname{div} \mathbf{a} = 0 \text{ on } \Omega, \quad \nu \cdot \mathbf{a} = 0 \text{ on } \partial\Omega.$

The vector field $\mathbf{a} = \mathbf{A} - \mathbf{F}$ satisfies the aforementioned conditions and (see [5, p. 143])

$$\nabla^{\perp}\operatorname{curl}(\mathbf{A} - \mathbf{F}) = -\Phi^{-1}\mathbf{j}(\psi, \mathbf{A}) \text{ on } \Omega, \quad \operatorname{curl}(\mathbf{A} - \mathbf{F}) = 0 \text{ on } \partial\Omega, \quad (2.3)$$

where $\nabla^{\perp} = (-\partial_{x_2}, \partial_{x_1})$ and $\mathbf{j}(\psi, \mathbf{A})$ is the supercurrent introduced in (1.5). We get then (2.2) with $C = 2C_{\Omega}$.

Starting with any sequence of minimizing configurations of \mathcal{E}_{Φ} , we can extract, by a standard compactness argument, limits of the magnetic potential and the modulus of the order parameter.

Proposition 2.5. Let $(\psi_{\Phi}, \mathbf{A}_{\Phi})_{\Phi>0} \subset \mathcal{H}$ be a family of configurations such that $(\psi_{\Phi}, \mathbf{A}_{\Phi})$ is a minimizer of \mathcal{E}_{Φ} for every $\Phi > 0$. Then, there exists a configuration $(\rho_*, \mathbf{a}_*) \in \mathcal{H}_0$ and a sequence (Φ_n) such that $\Phi_n \to +\infty$ and

$$|\psi_{\Phi_n}| \to \rho_*$$
 weakly in $H^1(\Omega; \mathbb{R})$ and strongly in $L^2(\Omega; \mathbb{R})$,

 $\Phi_n(\mathbf{A}_{\Phi_n} - \mathbf{F}) \to \mathbf{a}_*$ weakly in $H^2(\Omega; \mathbb{R}^2)$ and strongly in $H^1(\Omega; \mathbb{R}^2)$.

Proof. Let $\rho_{\Phi} = |\psi_{\Phi}|$ and $\mathbf{a}_{\Phi} = \Phi(\mathbf{A} - \mathbf{F})$. Thanks to Proposition 2.4, we have

 $\|\psi_{\Phi}\|_2^2 \le |\Omega|, \quad \|(-\mathrm{i}\nabla - \Phi \mathbf{A})\psi_{\Phi}\|_2^2 \le \kappa^2 |\Omega|, \quad \|\mathbf{a}_{\Phi}\|_{H^2(\Omega)}^2 \le C^2 \kappa^2 |\Omega|,$

and by the diamagnetic inequality, we get

$$\|\rho_{\Phi}\|_{2}^{2} + \|\nabla\rho_{\Phi}\|_{2}^{2} \le (1+\kappa^{2})|\Omega|.$$

By the Banach–Alaoglu theorem, we get a sequence (Φ_n) and a weak limit (ρ_*, \mathbf{a}_*) such that

$$\Phi_n \to +\infty, \quad \rho_{\Phi_n} \to \rho_* \text{ weakly in } H^1(\Omega; \mathbb{R}) \text{ and } \mathbf{a}_{\Phi_n} \to \mathbf{a}_* \text{ weakly in } H^2(\Omega; \mathbb{R}^2).$$

Thanks to the compact embeddings of $H^1(\Omega; \mathbb{R})$ and $H^2(\Omega; \mathbb{R}^2)$ in $L^2(\Omega; \mathbb{R})$ and $H^1(\Omega; \mathbb{R}^2)$ respectively, we can arrange for the sequences to converge strongly in $L^2(\Omega; \mathbb{R})$ and $H^1(\Omega; \mathbb{R}^2)$, respectively. The strong convergence in $H^1(\Omega; \mathbb{R}^2)$ yields

div
$$\mathbf{a}_* = 0$$
 on Ω , $\nu \cdot \mathbf{a}_* = 0$ on $\partial \Omega$.

hence $(\rho_*, \mathbf{a}_*) \in \mathcal{H}$. It remains to show that $\rho_* = 0$ on ω . For this, we write by (2.2) and Cauchy's inequality,

$$\|(-\mathrm{i}\nabla - \Phi \mathbf{A})\psi\|_{L^{2}(\omega)}^{2} \geq \frac{1}{2}\|(-\mathrm{i}\nabla - \Phi \mathbf{F})\psi\|_{L^{2}(\omega)}^{2} - \widehat{C}\kappa^{2}|\Omega|,$$

where \widehat{C} is a positive constant. Then, we use the min-max principle and write

$$\|(-\mathrm{i}\nabla - \Phi \mathbf{A})\psi\|_{L^{2}(\omega)}^{2} \geq \frac{1}{2}\lambda_{1}(\Phi \mathbf{F},\omega)\|\psi\|_{L^{2}(\omega)}^{2} - \widehat{C}\kappa^{2}|\Omega|,$$

where $\lambda_1(\Phi \mathbf{F}, \omega)$ is the lowest eigenvalue for $(-i\nabla - \Phi \mathbf{F})^2$ in $L^2(\omega)$, with Neumann boundary condition on ω . Knowing that $\lambda_1(\Phi \mathbf{F}, \omega) \to +\infty$ as $\Phi \to +\infty$ (see [5, Thm. 8.1.1]), we deduce that $\|\rho_{\Phi_n}\|_{L^2(\omega)} \to 0$, hence $\rho_* = 0$ on ω .

Our next task is to refine the convergence of the minimizing order parameter when restricted to Ω_0 .

Proposition 2.6. Let $(\psi_{\Phi}, \mathbf{A}_{\Phi})_{\Phi>0} \subset \mathcal{H}$ be a family of configurations such that $(\psi_{\Phi}, \mathbf{A}_{\Phi})$ is a minimizer of \mathcal{E}_{Φ} for every $\Phi > 0$. Then, there exists a sequence (Φ_n) and a function $u_* \in H^1(\Omega; \mathbb{C})$ such that $\Phi_n \to +\infty$ and

$$\begin{split} \mathcal{E}_{\Phi_n}(\psi_{\Phi_n}, \mathbf{A}_{\Phi_n}) &\geq \mathcal{G}(\Phi_n) + o(1), \\ U_{\lfloor \Phi_n \rfloor}^{-1} \psi_{\Phi_n} &\to \psi_* \text{ in } H^1(\Omega_0; \mathbb{C}), \\ \psi_* &= 0 \text{ on } \omega, \end{split}$$

where, for $k \in \mathbb{N}$, U_k is the function introduced in (1.13).

Proof. The proof relies on a compactness argument and the extraction of a subsequence. To simplify the exposition, we will skip the reference to the subsequence.

For $\Phi > 0$, we write $\Phi = \Phi_0 + n$ where $n = \lfloor \Phi \rfloor$ and $\Phi_0 = \{\Phi\} \in [0, 1)$. Without loss of generality, we will assume that Φ_0 is a fixed constant. Starting from $(\psi, \mathbf{A}) = (\psi_{\Phi}, \mathbf{A}_{\Phi})$, we put

$$\rho = |\psi|, \quad u = u_{\Phi} := U_n^{-1}\psi, \quad \mathbf{a} = \mathbf{a}_{\Phi} := \Phi_0 \mathbf{F} + \Phi(\mathbf{A} - \mathbf{F}),$$

and we observe by (2.2) that

$$\|\mathbf{a}\|_{H^2(\Omega)} \le C_0,$$

where C_0 is a positive constant, independent of Φ . Moreover, note that u is defined on Ω_0 , $|u| = \rho|_{\Omega_0}$, and the following identities hold in Ω_0 ,

$$(-\mathrm{i}\nabla - \mathbf{a})u = U_n^{-1}(-\mathrm{i}\nabla - \Phi \mathbf{A})\psi,$$
$$(-\mathrm{i}\nabla - \mathbf{a})^2 u = U_n^{-1}(-\mathrm{i}\nabla - \Phi \mathbf{A})^2 \psi = \kappa^2 (1 - |u|^2)u.$$

Consequently, with

$$0 < \varepsilon < \varepsilon_0 := \operatorname{dist}(\partial \omega, \partial \Omega), \quad \Omega_{\varepsilon} := \{ x \in \Omega_0 : \operatorname{dist}(x, \partial \omega) > \varepsilon \}, \qquad (2.4)$$

we have by Proposition 2.4 and elliptic estimates,

$$\|u\|_{H^2(\Omega_{\varepsilon})} \le C_{\varepsilon},$$

where C_{ε} depends on ε but is independent of Φ . Cantor's diagonal argument yields a sequence and a function $u_* \in H^2_{loc}(\Omega_0; \mathbb{C})$ such that, for $0 < \varepsilon < \varepsilon_0$,

$$u \to u_*$$
 weakly in $H^2(\Omega_{\varepsilon}; \mathbb{C})$ and strongly in $H^1(\Omega_{\varepsilon}; \mathbb{C})$, (2.5)

and by Propositions 2.4 and 2.5,

$$\|u_*\|_{\infty} \leq 1,$$

$$\rho \to \rho_* \text{ in } L^2(\Omega; \mathbb{R}) \text{ with } \rho_*|_{\omega} = 0,$$

$$\mathbf{a} \to \Phi_0 \mathbf{F} + \mathbf{a}_* \text{ in } H^1(\Omega; \mathbb{R}^2).$$
(2.6)

Consequently, $|u_*| = \rho_*|_{\Omega_0}$. Moreover, by monotone convergence

$$\int_{\Omega_0} |(-\mathrm{i}\nabla - \Phi_0 \mathbf{A}_*)u_*|^2 \,\mathrm{d}x = \lim_{\varepsilon \to 0_+} \int_{\Omega_\varepsilon} |(-\mathrm{i}\nabla - \Phi_0 \mathbf{A}_*)u_*|^2 \,\mathrm{d}x,$$

where

$$\mathbf{A}_{*} = \begin{cases} \mathbf{F} + \Phi_{0}^{-1} \mathbf{a}_{*} & \text{if } \Phi_{0} > 0, \\ \mathbf{F} & \text{if } \Phi_{0} = 0, \end{cases}$$

and we have by (2.5)-(2.6) and Proposition 2.4,

$$\forall \varepsilon \in (0, \varepsilon_0), \quad \int_{\Omega_{\varepsilon}} |(-\mathrm{i}\nabla - \Phi_0 \mathbf{A}_*) u_*|^2 \, \mathrm{d}x \leq \limsup_{\Phi \to +\infty} \int_{\Omega} |(-\mathrm{i}\nabla - \Phi \mathbf{A}) \psi|^2 \, \mathrm{d}x \leq \kappa^2 |\Omega|,$$

hence it follows that

$$\int_{\Omega_0} |(-\mathrm{i}\nabla - \Phi_0 \mathbf{A}_*) u_*|^2 \,\mathrm{d}x \le \kappa^2 |\Omega|.$$

Thus, we have $(u_*, \mathbf{A}_*) \in \mathcal{H}_0$ and, for $0 < \varepsilon < \varepsilon_0$,

$$\begin{split} \mathbf{E}(\Phi) &= \mathcal{E}_{\Phi}(\psi, \mathbf{A}) \\ &\geq \int_{\Omega_{\varepsilon}} \left(|(-\mathbf{i}\nabla - \mathbf{a})u|^2 + \frac{\kappa^2}{2} |u|^4 \right) \mathrm{d}x - \kappa^2 \int_{\Omega} \rho^2 \,\mathrm{d}x + \int_{\Omega} |\operatorname{curl} \mathbf{a}|^2 \,\mathrm{d}x. \end{split}$$

Sending $\Phi \to +\infty$ (along the sequence (Φ_n)) and then $\varepsilon \to 0$, we get by monotone convergence

$$\liminf_{\Phi_n \to +\infty} \mathcal{E}(\Phi) \ge \mathcal{G}_{\Phi_0}(u_*, \mathbf{A}_*) \ge \mathcal{G}(\Phi_0).$$

To finish the proof, we use Propositions 2.3 and 2.1, and this yields that (u_*, \mathbf{A}_*) is a minimizer of \mathcal{G}_{Φ_0} .

Collecting Proposition 2.3 and 2.6, we get the conclusion of Theorem 1.1. Corollary 1.3 also results from a standard argument, and we refer to the proof of [12, Corollary 1.5] for details.

3. The effective eigenvalue and oscillations under local fields

In this section we prove Theorem 1.4, from which Corollary 1.5 follows by a standard argument (see [12, Proof of Thm. 1.7(2)]).

For every $\Phi > 0$, let u_{Φ} denote a normalized ground state of $\lambda_1^{\Omega}(\Phi)$. Similar to Proposition 2.5, we can prove that the function $\rho_{\Phi} := |u_{\Phi}|$ is bounded in $H^1(\Omega; \mathbb{R})$.

Proposition 3.1. There exist positive constants C_1 , Φ_1 such that, for all $\Phi \ge \Phi_1$, we have

$$\|\rho_{\Phi}\|_{H^1(\Omega;\mathbb{R})} \le C_1$$

and

$$\int_{\omega} |\rho_{\Phi}|^2 \, \mathrm{d}x \le \frac{C_1}{\Phi}.$$

Proof. The first inequality is the consequence of Proposition 1.2 and the non-asymptotic bound in (1.24). The second inequality follows from the min-max principle,

$$\lambda_1(\Phi \mathbf{F}, \omega) \int_{\omega} |\rho_{\Phi}|^2 \, \mathrm{d}x \le \lambda_1^{\Omega}(\Phi),$$

where $\lambda_1(\Phi \mathbf{F}, \Omega)$ is the lowest eigenvalue for $(-i\nabla - \Phi \mathbf{F})^2$ in $L^2(\omega)$, with Neumann boundary condition on ω . We obtain the desired inequality thanks to the known asymptotics $\lambda_1(\Phi \mathbf{F}, \omega) \sim \Theta_0 |\operatorname{curl} \mathbf{F}| \Phi$, where $\Theta_0 \approx 0.59$ is the de Gennes constant (see [5, Thm. 8.1.1]).

Next we define the function v_{Φ} on Ω_0 as

$$v_{\Phi} = U_n^{-1} u_{\Phi}, \quad n = \lfloor \Phi \rfloor,$$

where U_n is the function introduced in (1.13). Similar to Proposition 2.6, we can prove that v_{Φ} is bounded locally in $H^2(\Omega_0)$. **Proposition 3.2.** Let $0 < \varepsilon < \varepsilon_0 := \text{dist}(\partial \omega, \partial \Omega)$. There exist positive constants $C_{\varepsilon}, \Phi_{\varepsilon}$ such that, for all $\Phi \ge \Phi_{\varepsilon}$, we have

$$||v_{\Phi}||_{H^2(\Omega_{\varepsilon};\mathbb{C})} \leq C_{\varepsilon},$$

where Ω_{ε} is introduced in (2.4).

Proof. With $\Phi_0 = \{\Phi\}$, we have

$$(-i\nabla - \Phi_0 \mathbf{F})^2 v_{\Phi} = \lambda_1^{\Omega}(b) v_{\Phi} \text{ on } \Omega_0.$$

The bound in $H^2(\Omega_{\varepsilon}, \mathbb{C})$ is the result of elliptic L^2 estimates.

Remark 3.3. Thanks to Proposition 3.1, the function v_{Φ} is almost normalized in $L^2(\Omega_0)$; in fact, we have as $\Phi \to +\infty$,

$$\int_{\Omega_0} |v_\Phi|^2 \,\mathrm{d}x = 1 + \mathcal{O}(1/\Phi)$$

Proof of Theorem 1.4. Thanks to (1.24), we have

$$\limsup_{\Phi \to +\infty} \left(\lambda_1^{\Omega}(\Phi) - \lambda_1^{\Omega_0}(\Phi) \right) \le 0.$$

so it suffices to show that

$$\liminf_{\Phi \to +\infty} \left(\lambda_1^{\Omega}(\Phi) - \lambda_1^{\Omega_0}(\Phi) \right) \ge 0$$

If this does not hold, then there exist a positive constant c_* and an unbounded set $\mathcal{I} \subset \mathbb{R}_+$ such that,

$$\forall \Phi \in \mathcal{I}, \quad \lambda_1^{\Omega}(\Phi) - \lambda_1^{\Omega_0}(\Phi) < -c_*. \tag{3.1}$$

Since $(\rho_{\Phi})_{\Phi \in \mathcal{I}}$ is bounded in $H^1(\Omega; \mathbb{R})$, and $(v_{\Phi})_{\Phi \in \mathcal{I}}$ is bounded in $H^2(\Omega_{\varepsilon}; \mathbb{C})$ for every $\varepsilon < \varepsilon_0$, there are functions

$$\rho_* \in H^1(\Omega; \mathbb{R}), \quad v_* \in H^2_{\text{loc}}(\Omega_0; \mathbb{C}),$$

and a sequence $(\Phi_k) \subset \mathcal{I}$ such that

$$\Phi_k \to +\infty, \quad \{\Phi_k\} \to \Phi_* \in [0,1],$$

and

$$\rho_{\Phi_k} \to \rho_*$$
 strongly in $L^2(\Omega; \mathbb{R}), \quad v_{\Phi_k} \to v_*$ strongly in $H^1(\Omega_{\varepsilon})$

Moreover, we have

$$\int_{\Omega_{\varepsilon}} |(-\mathrm{i}\nabla - \{\Phi_k\}\mathbf{F})v_{\Phi_k}|^2 \,\mathrm{d}x = \int_{\Omega_{\varepsilon}} |(-\mathrm{i}\nabla - \Phi_k\mathbf{F})u_{\Phi_k}|^2 \,\mathrm{d}x \le \lambda_1^{\Omega}(\Phi_k) \le \lambda_1^{\Omega}(1/2),$$

so that, by taking $k \to +\infty$ then $\varepsilon \to 0_+$ we have by monotone convergence

$$\int_{\Omega_0} |\nabla v_*|^2 \, \mathrm{d}x \le \|\mathbf{F}\|_{\infty}^2 + \lambda_1^{\Omega}(1/2).$$

Thus, $v_* \in H^1(\Omega_0; \mathbb{C})$ and $|v_*| = \rho_*$. By Proposition 3.1 we get that $\rho_*|_{\partial \omega} = 0$, hence $v_*|_{\partial \omega} = 0$, and by Remark 3.3, we have $\int_{\Omega_0} |v_*|^2 dx = 1$.

Finally, for ever $0 < \varepsilon < \varepsilon_0$, we have

$$\lambda_1^{\Omega}(\Phi_k) \ge \int_{\Omega_{\varepsilon}} |(-\mathrm{i}\nabla - \{\Phi_k\}\mathbf{F})v_{b_k}|^2 \,\mathrm{d}x,$$

and by taking $k \to +\infty$, we get

$$\limsup_{k \to +\infty} \lambda_1^{\Omega}(\Phi_k) \ge \int_{\Omega_{\varepsilon}} |(-\mathrm{i}\nabla - \Phi_* \mathbf{F}) v_*|^2 \,\mathrm{d}x,$$

$$\limsup_{k \to +\infty} \lambda_1^{\Omega}(\Phi_k) \ge \int_{\Omega_0} |(-i\nabla - \Phi_* \mathbf{F}) v_*|^2 \, \mathrm{d}x \ge \lambda_1^{\Omega_0}(\Phi_*),$$

and eventually

$$\limsup_{k \to +\infty} \left(\lambda_1^{\Omega}(\Phi_k) - \lambda_1^{\Omega_0}(\Phi_k) \right) \ge 0$$

which violates (3.1).
